### ACUMEN PORTFOLIOS

The ACUMEN Portfolios are low cost sub-funds of the ACUMEN Open Ended Investment Company (OEIC) and are comprised of index tracking ETFs. The portfolios provide multi-asset, global coverage with wide diversification across shares in companies, bond, commodity and property markets. The portfolios are regulated to the “gold” standard of European regulation - UCITS compliant. The Authorised Corporate Director for the ACUMEN Portfolios is Investment Fund Services Limited.

### INVESTMENT OBJECTIVE

The aim of ACUMEN Portfolio 6 is to increase in value, over a minimum of 5 years, by investing in a range of asset classes and global markets. This will be achieved through a combination of capital growth, which is profit on investments held, and income, which is money paid out of investments such as dividends from shares and interest from bonds.

The portfolio aims to outperform its Market Composite Benchmark over any 3-year period, however, there is no certainty this will be achieved. For more information on the Market Composite Benchmark please refer to the fund prospectus.

### INVESTMENT POLICY

ACUMEN Portfolio 6 will be actively managed, on a high medium risk strategy. It will aim to maintain a risk rating classification of 6, as set by an independent risk profiling company. The independent risk profiling company has a risk rating range from 1 (lowest risk) to 10 (highest risk).

The portfolio will invest in a number of different asset classes across global markets, including shares in companies, bonds, property and commodities. The asset class exposure over an investment cycle will broadly reflect the Market Composite Benchmark as defined below.

### PERFORMANCE TARGET – MARKET COMPOSITE BENCHMARK

The Market Composite Benchmark for ACUMEN Portfolio 6 is comprised as follows:

- **22% Bonds** -
  - Bloomberg Barclays Global Aggregate Bond GBP Hedged Index (20%)
  - Bloomberg Barclays Global High Yield Bond GBP Hedged Index (2%)
- **73% Equities** -
  - MSCI World Index GBP Hedged (63%)
  - MSCI Emerging Markets Investable Market Index (10%)
- **5% Cash** -
  - Sterling Overnight Index Average (5%)

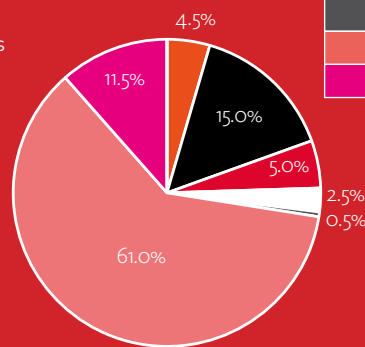
ACUMEN Portfolio 6 has been independently risk profiled by Dynamic Planner:

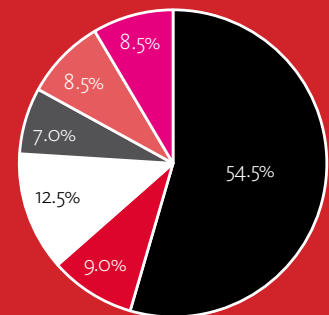


## HOW/WHERE IS THE FUND INVESTED?

## HOW MUCH DOES IT COST?
